  - Criteria for Leave of Absence by Students, etc.

# (1) Criteria for Leave of Absence by Students

The criteria for leave of absence shall be provided as below as a significant matter regarding the status of students set forth in Article 4, paragraph 1, item 8 of the University of Tokyo Rules on Education and Research Council.

#### Article 1

Any students who fall under any of the following may be permitted to take a leave of absence pursuant to the provision of Article 19, paragraph 2 of the University of Tokyo General Rules on College/Faculties:

- (1) Students who need to take a leave of absence for two months or more to study at an educational or research facility abroad;
- (2) Students who need to take a leave of absence for two months or more to carry out research or for a field observation abroad;
- (3) Students who need to take a leave of absence for two months or more due to financial reasons;
- (4) Students who are foreign students and who need to take a leave of absence for two months or more to temporarily return home due to any unavoidable reason;
- (5) Students who need to take a leave of absence for two months or more to for childbirth or to take care of children;
- (6) Students who need to take a leave of absence for two months or more to take care of a spouse (including any person who has not filed a marriage notification but is actually in a relationship equivalent to a marriage), parent, child, parent of a spouse or any other person separately stipulated by the President whose injury, sickness or age interferes with their everyday lifestyle;

- (7) Students who need to take a leave of absence for two months or more to participate in an activity separately stipulated by the President in which the student voluntarily contributes to society;
- (8) Students from the School of Medicine of the Faculty of Medicine who need to take a leave of absence to enroll in a Doctoral program in which the student studies medicine at the graduate level of the University of Tokyo pursuant to the provision of Article 16, paragraph 3, item 8 of the University of Tokyo Rules on Graduate Schools;
- (9) Students who are foreign students and need to take a leave of absence for two months or more since their certificate of eligibility has not been issued, and therefore they cannot enter Japan; or
- (10) In addition to students described in (1) to (9), students who need to take a leave of absence for two months or more due to a situation where an opportunity for education or research is not guaranteed regardless of the student's intention.

#### Article 2

The University of Tokyo may order any students who fall under any of the following to take a leave of absence pursuant to the provision of Article 19, paragraph 4 of the University of Tokyo General Rules on College/Faculties:

- (1) Students who are deemed inappropriate to study at the University of Tokyo due to an infectious disease; or
- (2) Students who are deemed inappropriate to study at the University of Tokyo due to a psychological disorder.

# (2) Extent of Persons Requiring Nursing Care and Social Service Activities Pertaining to Student Leave of Absence Standards

President's Ruling January 21, 2003

- **1.** Persons separately determined by the President in Article 1 No. 6 of the *Criteria for Leave of Absence by Students* shall refer to the following persons who live with the student in question.
- (i) Grandparents and siblings.
- (ii) Persons listed below who are recognized as being in relationships equivalent to actual parents of the student or the student's spouse (including persons in circumstances equivalent to actual martial relations although for which no notification has been made), or persons recognized as being in relationships equivalent to actual children of the student.
  - a) Spouse of the student's parent
  - b) Spouse of a parent of the student's spouse
  - c) Spouse of the student's child
  - d) Child of the student's spouse
  - e) Grandchild (limited to persons with both parents deceased)
- **2.** Activities separately determined by the President in Article 1 No. 7 of the *Criteria for Leave of Absence by Students* shall refer to the following.
- (i) Activities involving participation in the Japan Overseas Cooperation Volunteers or other organizations involved in international cooperation.
- (ii) Cases of students engaging in social service activities (excluding activities consisting exclusively of support for relatives) on a voluntary basis and without receiving remuneration that correspond to any of the following matters, and for which taking leave of absence is recognized as being appropriate.
  - a) Distribution of subsistence goods in disaster-stricken areas or vicinities suffering damage of considerable scale from earthquakes, rainstorms, volcanic eruptions or other disasters, or other activities supporting the victims of such disasters.
  - b) Activities at nursing homes for persons with physical disabilities, special nursing

- homes for the elderly and other facilities operated primarily for the purpose of providing measures necessary for persons with physical or mental disabilities or persons suffering from illnesses.
- c) In addition to the activities in "a" and "b" above, nursing care and other daily life support activities for persons for whom physical or mental disabilities, injury or illness interferes with their everyday lives.

# (3) Handling of a Special Leave of Absence During the First Year

Education and Research Council
November 27, 2012

The handling of a special leave of absence during the first year (hereinafter referred to as "special leave of absence during the first year") described in Article 19-2 of the University of Tokyo General Rules on College/Faculties shall be as follows.

- 1. The Dean of the College of Arts and Sciences may permit a student who is selected to a long-term independent activity program during the first year to take a special leave of absence during the first year.
- 2. The period of a special leave of absence during the first year shall be from the beginning of the academic year to the end of the year and no extension of the period is permitted.
- 3. Return to the University of Tokyo during the period in the preceding article shall not be permitted except under unavoidable circumstances.
- 4. The handling shall come into force on April 1, 2013.

# (4) Reason for and Period of Leave of Absence Not Included in Period of Leave of Absence

March 19, 2024

The reason for and period of a leave of absence that may not be included in the period of the leave of absence described in Article 20, paragraph 4 of the University of Tokyo General Rules on College/Faculties (including as applied *mutatis mutandis* pursuant to Article 29, paragraph 2 of the University of Tokyo Rules on Graduate Schools and Article 18, paragraph 2 of the University of Tokyo Rules on Professional Graduate Schools) shall

be as follows.

#### Article 1

The reason for and period of a leave of absence that may not be included in the period of the leave of absence shall be as stipulated in the following items. However, the dean of a faculty/college, graduate school needs to listen to the opinion of the Education Steering Committee in determining whether there is a reason described in (3) or not, or whether such reason continues to exist or not.

- (1) Students who fall under Article 1, item (4) of the Criteria for Leave of Absence by Students, etc., and who serve an obligation pursuant to the laws and regulations of their country of origin: Period to serve the obligation for no longer than two years
- (2) Students who fall under Article 1, item (9) of the Criteria for Leave of Absence by Students, etc.: Within one year
- (3) Students who fall under Article 1, item (10) of the Criteria for Leave of Absence by Students, etc.: Within one year

#### Article 2

Regardless of the provisions of the preceding article, if the student falls under item (2) or item (3) of the previous article and if the dean of a faculty/college, graduate school or education unit acknowledges that the reason continues to exist even after the period, the period when the reason continues to exist may not be included in the period of the leave of absence. In such case, the dean of a faculty/college, graduate school or education unit shall determine whether the reason continues to exist or not for each period described in item (2) or item (3) of the article.
