Chapter 1 General Provisions

Article 1 General Rules

All matters regarding the curriculum, examinations and graduation of the Faculty of Medicine of the University of Tokyo (hereinafter referred to as the "Faculty") shall be subject to these Rules in addition to the provisions of the University of Tokyo General Rules on Faculties. However, the faculty council may set out exceptional provisions regardless of these Rules if there is any special circumstance.

Article 1-2 Educational and Research Purpose

- 1. The purpose of the Faculty is to develop human resources who will contribute to the development of life science, medicine and medical treatment fields and be international leaders. Accordingly, the Faculty aims to have students who conduct creative research for accurate comprehension of and solutions to problems in those fields and who are able to practice holistic medicine based on the result of such research.
- 2. The purpose regarding human resource development by each department and other educational and research purposes shall be prescribed separately.

Article 2 Departments

The following two departments are established in the Faculty:

School of Medicine

School of Integrated Health Sciences

Article 3 Semesters

The academic year shall be divided into the following two semesters.

Summer Semester: April 1 through September 30

Winter Semester: October 1 through March 31 of the following year

Article 4 Advancement

Students who wish to advance to the Faculty shall have completed the required courses in the College of Arts and Sciences and acquired necessary number of credits.

Article 5 Readmission, Admission to Senior Division and Transfer to Another Faculty or Department

Handling of readmission set out in Article 9 and Article 10 of the University of Tokyo Rules on Faculties, admission to the Senior Division excluding those stipulated in the preceding two Articles and transfer to another faculty or department shall be prescribed separately.

Chapter 2 School of Medicine

Article 6 Curriculum

The courses and course hours of the School of Medicine shall be as set out in Appended Table 1.

Article 7 Tutors

- 1. The School of Medicine arranges tutors for students to comprehend and receive guidance for study and to consult with regarding school life.
- 2. Tutors are appointed from academic staff of the Faculty.

Article 8 Examinations

- 1. Students will take examinations for the compulsory courses set out in Appended Table 1.
- 2. The timing of examinations shall be prescribed separately.
- 3. Any student who is deemed to have done insufficient study due to the student's absence from the University of Tokyo or his or her attendance for any practical course not amounting to four-fifths of the total number of hours of the course may not be permitted to take examinations.

Article 9 Notification of Absence from Examinations

- 1. Any student who does not take an examination due to sickness or other unavoidable circumstances shall obtain approval from the teacher in charge of the course and the tutor and submit the notification of absence from examination (with a medical certificate in the case of sickness or specific statement of the reason in the case of any other circumstances) to the dean of the Faculty of Medicine within the five day period before and five day period after the date of the examination.
- 2. Students who deliver the notification set out in the preceding paragraph will take a makeup examination and students who do not deliver the notification will be treated as

having failed the examination and shall not take a makeup examination until the same time in the following year.

Article 10 Grades

- 1. The assessment of examination grades may be classified into A+, A, B, C and F; the grades A+, A, B and C are a pass and F is a fail.
- 2. The criteria for the assessment set out in the preceding paragraph shall be prescribed separately.
- 3. Any student who obtained a fail grade for examination may retake the examination.

Article 11 Makeup Examinations and Retaking Examinations

Matters regarding makeup examinations and retaking examinations shall be prescribed separately.

Article 12 Progression through Educational Levels

Matters regarding progression through educational levels shall be prescribed separately.

Article 13 Clinical Training

Students who have completed the courses prescribed in Appended Table 2 and passed the examination may attend clinical training.

Article 14 Graduation

Any student who has been enrolled in the Faculty for at least four years and completed the compulsory courses prescribed in Appended Table 1 and passed the examination shall be a graduate of the Faculty and conferred a Bachelor of Medicine.

Chapter 3 School of Integrated Health Sciences

Article 15 Course and Number of Credits

The courses and the number of credits of the School of Integrated Health Sciences shall be as set out in Appended Table 3.

Article 16 Tutor

- 1. A tutor shall be allocated to ascertain the state of the students' performance and give instructions as well as to be able to discuss and advise on general affairs of life.
- 2. A tutor shall be a member of the academic staff of this Faculty.

Article 17 Course Registration

- 1. Students shall register for a course each academic year by the designated date of the courses they intend to take.
- 2. Students shall not take any course for which they have not registered.

Article 18 Specialized Courses

Students shall acquire 84 credits or more of specialized courses pursuant to the provisions of Appended Table 3.

Article 19 Examinations

Students will take examinations for lectures and practical courses at the end of each semester. However, the grade for practice courses may be determined based on the number of days

attended, number of practical courses attended, results achieved and other matters.

Article 20 Application for Examinations

- 1. Students who intend to take an examination shall make an application therefor by one week before the date of the examination.
- 2. If any student who applied for an examination will be absent on the date of the examination due to sickness or other unavoidable circumstances, the student shall submit the cancellation of application for examination with the statement of reason (medical certificate in the case of sickness or specific statement of reason in the case of any other circumstances) to the dean of the Faculty within the five day period before and five day period after the date of examination.
- 3. Any student who made an application set out in the preceding paragraph may take a makeup examination.
- 4. If any student who applied for an examination was absent on the date of the examination and did not make any application by the date set out in the preceding paragraph, the student will be treated as having failed and shall not take the examination until the same time in the following year.

Article 21 Grades

- 1. The assessment of examination grades may be classified into A+, A, B, C, and F; the grades A+, A, B, and C represent a pass and F represents a fail. However, the assessment for a graduation thesis is pass or failure.
- 2. The criteria for the assessment set out in the preceding paragraph shall be prescribed separately.
- 3. Any student who obtained a failure grade for examination may retake the examination.

Article 22 Makeup Examinations and Retaking Examinations

Matters regarding makeup examinations and retaking examinations shall be prescribed separately.

Article 23 Graduation

Any student who has been enrolled in the Faculty for at least the period prescribed in the University of Tokyo General Rules on Faculties, completed the required courses and acquired necessary credits shall be a graduate of the Faculty and conferred a Bachelor of Health Science.

Supplementary Provisions

- 1. These Rules shall come into force on April 1, 1990.
- 2. With regard to persons who entered the Faculty on or before March 31, 1990, the provisions in force then shall remain applicable.

Supplementary Provisions

- 1. These Rules shall come into force on April 1, 1991.
- 2. With regard to persons who entered the Faculty on or before March 31, 1991, the provisions in force then shall remain applicable.

- 1. These Rules shall come into force on April 1, 1992.
- 2. With regard to persons who entered the Faculty on or before March 31, 1992, the provisions in force then shall remain applicable.

Supplementary Provisions

- 1. These Rules shall come into force on April 28, 1992 and shall be applicable from April 1, 1992.
- 2. With regard to persons who entered the Faculty on or before March 31, 1992 and are still enrolled, the provisions in force then shall remain applicable.

Supplementary Provisions

- 1. These Rules shall come into force on June 29, 1993 and the revised provisions of the University of Tokyo Rules for the Faculty of Medicine shall be applicable on April 1, 1993.
- 2. With regard to persons who entered the Faculty on or before March 31, 1993, the provisions in force then shall remain applicable.

Supplementary Provisions

- 1. These Rules shall come into force on April 1, 1995.
- 2. With regard to persons who entered the School of Medicine of the Faculty of Medicine on or before March 31, 1995 and are still enrolled, the provisions in force then shall remain applicable.

Supplementary Provisions

- 1. These Rules shall come into force on May 16, 1995.
- 2. With regard to persons who entered the School of Health Sciences of the Faculty of Medicine on or before March 31, 1994 and are still enrolled, the provisions in force then shall remain applicable.

Supplementary Provisions

- 1. These Rules shall come into force on April 1, 1997.
- 2. With regard to persons who entered the Faculty on or before March 31, 1997, the provisions in force then shall remain applicable.

Supplementary Provisions

- 1. These Rules shall come into force on October 1, 1998. However, the courses and the number of credits set out in Appended Table 3 [Elective Courses] and the part of the remarks in Appended Table 3 that are under revision shall come into force on April 1, 1999.
- 2. With regard to persons who entered the School of Health Sciences and Nursing of the Faculty of Medicine on or before March 31, 1999, the provisions in force then shall remain applicable.
- 3. With regard to persons who entered the undergraduate program Junior Division of the University of Tokyo on or before March 31, 1997, the provisions in force then shall remain applicable.

- 1. These Rules shall come into force on April 1, 2003.
- 2. Notwithstanding the provisions of the revised Article 8-2, Article 9, paragraph 3, Article 10 and Article 12-2, the provisions before revision shall apply to persons who entered the Faculty on or before March 31, 2003.

Supplementary Provisions

- 1. These Rules shall come into force on October 1, 2003.
- 2. Notwithstanding the provisions of the revised Appended Table 3 (in relation to Article 15), the provisions before revision shall apply to persons who entered the School of Health Sciences and Nursing of the Faculty of Medicine on or before March 31, 2004.

Supplementary Provisions

- 1. These Rules shall come into force on April 1, 2004.
- 2. Notwithstanding the provisions of the revised Appended Table 3 (in relation to Article 15), the provisions before revision shall apply to persons who entered the undergraduate program Junior Division of the University of Tokyo on or before March 31, 2004.

Supplementary Provisions

- 1. These Rules shall come into force on April 1, 2004.
- 2. Notwithstanding the provisions of the revised Appended Tables, the provisions before revision shall apply to persons who entered the Faculty on or before March 31, 2004.

Supplementary Provisions

These Rules shall come into force on January 1, 2005.

Supplementary Provisions

- 1. These Rules shall come into force on April 1, 2006.
