### Article 1 Educational and Research Purposes

1. The purpose of the Faculty of Agriculture of the University of Tokyo (hereinafter referred to as the “Faculty”) is to provide education in the various applied sciences constituting agriculture in stages and systematically, and to develop human resources who have sophisticated expertise and the wide vision necessary to resolve issues regarding foods, resources and the environment and who have insight, power of execution and leadership to respond to demands by the global society through social, cultural and industrial activities.
2. The purpose of developing human resources and other educational and research purposes for each course shall be prescribed separately.

### Article 2 Departments

The following three departments (14 majors) are established at the Faculty:

Applied Life Science Course (Major in Biological Chemistry and Biotechnology, Major

in Applied Biology, Major in Forest Life Science, Major in Aquatic Bioscience, Major in Animal Life Sciences and Major in Biobased Materials Chemistry)  
Environmental and Resource Science Course (Major in Landscape Environment, Major in Forest Environmental and Resource Science, Major in Wood Science and Timber Engineering, Major in Biological and Environmental Engineering, Major in Agricultural and Resource Economics, Major in Field Science and Major in International Sustainable Agriculture Development)  
Veterinary Medical Sciences Course (Major in Veterinary Medical Sciences)

### **Article 3 Classification of Courses**

Courses consist of compulsory courses, elective compulsory courses and elective courses.

### **Article 4 Courses and Number of Credits**

1. Faculty courses and the number of credits therefor are as prescribed in Schedule 1.
2. The faculty council determines the allocation of courses for each semester.

### **Article 5 Courses of Other Faculties**

1. Students may take courses of other faculties as elective courses.
2. Courses and number of credits therefor pursuant to the preceding paragraph are subject to the approval by the Faculty board members and limited to the number of credits prescribed in Schedule 1, and may be included in the credits prescribed in Article 11.

### **Article 6 Course Registration**

1. Students must register for courses they intend to take by the designated date in each academic year or each semester and obtain approval from the relevant Faculty board members.
2. Persons who intend to take courses of other faculties must obtain permission from the dean of the Faculty and the deans of the relevant faculties.

### **Article 7 Application for Examinations**

Students may take examinations for the courses that are approved or permitted pursuant to the provisions of the preceding Article after applying for such examinations by the designated date.

### **Article 8 Examinations**

End-of semester examinations for the same courses shall be held annually at the end of each semester for the courses for which the classes are completed in the relevant semester. However, the academic staff in charge of the course may hold interim examinations upon obtaining approval from the dean of the Faculty.

### **Article 9 Assessment of Examination Results**

1. The examination results shall be graded as A+, A, B, C and F. The grade of F results in a fail of the course.
2. Pursuant to the provisions of Articles 14-2 and 14-3 of the University of Tokyo General Rules on Faculties (hereinafter referred to as the “General Rules on Faculties”), except for the grades prescribed in the preceding paragraph, the examination results for courses taken at a university abroad may be graded as pass or fail.

### **Article 10 Assessment Without Examination**

The results of exercises, experiments and practical training may be used for assessment

without any examination.

### **Article 11 Graduation**

Students must be enrolled in the Faculty at least for the period prescribed in Article 2 of the General Rules on Faculties, complete at least 84 credits of the courses prescribed in Schedule 1, and pass examinations therefor to graduate from the Faculty of Agriculture and obtain a Bachelor of Agriculture. However, students must complete at least 158.5 credits of the courses prescribed in Schedule 1, and pass examinations therefor to graduate from the Veterinary Medical Sciences program and obtain a Bachelor of Veterinary Medicine.

### **Article 12 Transfer**

Pursuant to the provisions of Article 10, paragraph 1, item (6) of the General Rules on Faculties, persons who have graduated from a 5-year engineering high school and who apply for admission to the Faculty, may be permitted to be admitted as prescribed separately.

### **Article 13**

1. The program duration, maximum period of enrollment and period of a leave of absence of persons who are admitted to the Faculty pursuant to the provisions of Article 16 are as follows:
  - (1) Program Duration: three years
  - (2) Maximum Period of Enrollment: five years
  - (3) Period of Leave of Absence: two years or less
2. The courses and number of credits to be taken by the persons who are admitted to the Faculty pursuant to the provisions of Article 12 will be treated as prescribed separately.

### **Article 14 Readmission, Admission to Senior Division, Transfer to Another Faculty and Transfer to Another Department**

The treatment of the provisions of Article 9, Article 10 (excluding the provisions prescribed in the preceding two Articles) and Article 45 shall be as prescribed separately.

### **Supplementary Provisions**

1. These Rules shall come into force on April 1, 1986.
2. With regard to persons who entered the Faculty on or before March 31, 1986 and are still enrolled, the provisions in force then shall remain applicable.

1. These Rules shall come into force on April 1, 2006.
2. Notwithstanding the provisions of the revised University of Tokyo Rules for the Faculty of Agriculture, the provisions before revision shall apply to persons who entered on or before March 31, 2006.
3. Persons may enter the reformed Applied Life Science Course, Environmental and Resource Science Course or Veterinary Medical Sciences Course on and after April 1,

2008.

4. The transitional measures associated with the revision shall be as prescribed separately.

#### **Supplementary Provisions**

1. These Rules shall come into force on April 1, 2006.
2. Notwithstanding the provisions of the revised University of Tokyo Rules for the Faculty of Agriculture, the provisions before revision shall apply to persons who entered on or before March 31, 2006.

#### **Supplementary Provisions**

1. These Rules shall come into force on April 1, 2006. However, the provisions of the revised University of Tokyo Rules for the Faculty of Agriculture shall apply to persons who entered on or after April 1, 2008.

4. The transitional measures associated with the revision shall be as prescribed separately.

2. Notwithstanding the provisions of the revised University of Tokyo Rules for the Faculty of Agriculture, the provisions before revision shall apply to persons who entered on or before March 31, 2012.

#### **Supplementary Provisions**

1. These Rules shall come into force on April 1, 2013.
2. Notwithstanding the provisions of the revised University of Tokyo Rules for the Faculty

of Agriculture, the provisions before revision shall apply to persons who entered on or before March 31, 2013.

**Supplementary Provisions**

1. These Rules shall come into force on April 1, 2014.
2. Notwithstanding the provisions of Appended Table 1 of the revised University of Tokyo Rules for the Faculty of Agriculture, the provisions before revision shall apply to persons who entered the Faculty of Agriculture on or before March 31, 2014 and are still enrolled.
