Detailed Rules Regarding Student Advisers

Established on October 26, 2004

Revised on
April 1, 2010

The University of Tokyo Rule No. 254

Article 1 Purpose

The purpose of these Detailed Rules is to provide the details regarding students constituting the student adviser group (hereinafter referred to as the “student advisers”) and the student advisers constituting the adviser group (hereinafter referred to as the “student members”) set forth in Article 12 of the University of Tokyo Regulations on Disciplinary Action against Student (hereinafter referred to as the “Regulations”).

Article 2 Election of Student Advisers

1. The election of the student advisers set forth in Article 12, paragraph 5 of the Regulations is subject to the following procedures.
2. The number of student advisers elected from each academic organization is as set out in the Appended Table.
3. The dean or director of the academic organization elects student advisers by lottery from the students who belong to the academic organization (excluding students on a leave of absence). The dean or director of the academic organization submits a register of the student advisers elected to the President.
4. The student advisers elected shall not decline their election, in principle.
5. The term of office of student advisers is one year.
6. In the case of a vacancy in the position of student advisers, the relevant academic organization must immediately fill such vacancy. The term of office of student advisers elected as a replacement is same as the remaining term of office of the previous student adviser.
7. The President shall deliver to each elected student adviser a document stating that the student is a student adviser.

Article 3 Organization and General Affairs of Student Adviser Group

1. The student adviser group has one president and two vice presidents.
2. The president and vice presidents are elected from among the student advisers.
3. If the election of the student members set forth in Article 12, paragraph 5 of the Regulations becomes necessary, the president or the vice president shall convene the student adviser group and the student members shall be elected by from among the student advisers.
4. The general affairs of the student adviser group are handled by the Student Support Group.

Article 4 Treatment of Student Members

The student members set forth in Article 12, paragraph 5 of the Regulations are paid an honorarium by the University of Tokyo.

Article 5 Disclosure of Names of Student Advisors and Names of Student Members

1. The names of the student advisors are disclosed.
2. The names of the student members are not disclosed.

Article 6 Observation of Judgment by Student Advisors

Any student adviser may observe an explanation and judgment set forth in Article 13 of the Regulations made by the adviser group to which that student adviser is not a student member unless the student subject to disciplinary action does not want that student adviser to observe.

Article 7 Revision and Abolishment of Detailed Rules

The revision or abolishment of these Detailed Rules will be made by the President upon discussion by the Student Life Committee.

Supplementary Provisions

1. These Rules shall come into force on January 1, 2005.
2. The term of office of the first student advisers elected after the enforcement of these Detailed Rules ends on March 31, 2005 notwithstanding the provision of Article 2, paragraph 5 hereof.

Supplementary Provisions

These Rules shall come into force on July 1, 2007.

Agreed Matters

If a judgment is incomplete at the time of expiration of the term of office as a student adviser, a student member may, as long as it is a student of the University of Tokyo and notwithstanding the provision of Article 2, paragraph 5 of these Detailed Rules, extend its term of office as a student adviser and serve as student member until the time the judgment is made. Even in such case, the relevant academic organization shall elect the fixed number of subsequent student advisers by the regular time of expiration of the term of office.

Supplementary Provisions

These Rules shall come into force on April 1, 2010.

Any academic organization in which 500 students or more are enrolled shall elect 2 student advisers.

Any academic organization in which less than 500 students are enrolled shall elect 1 student adviser.

The College of Arts and Sciences shall elect two student advisers from the junior division and one student adviser from the senior division.

The number of students enrolled is the number as of May 1, 2004.

The numbers shall be reviewed if any significant change occurs.
