Article 1 Purpose

The purpose of these Rules is to stipulate matters set out in the University of Tokyo General Rules on Faculties (hereinafter referred to as the “General Rules on Faculties”) to be determined by each faculty and matters that the Faculty of Pharmaceutical Sciences at the University of Tokyo (hereinafter referred to as the “Faculty”) deems necessary.

Article 1-2 Educational and Research Purpose

1. Pharmaceutical science is an academic discipline that aims for development of pharmaceuticals and their proper applications, encompassing life-related substances and their interactions with living bodies. The educational and research purpose of the Faculty is to train researchers who will contribute to the development of drug discovery and basic life sciences, human resources who will contribute to health services and pharmacists who will support advanced treatment.
2. The purpose regarding the development of human resources in each department and other educational research purposes shall be prescribed separately.

Article 2 Departments

The following departments are established in the Faculty.

Department of Pharmaceutical Sciences
Department of Pharmacy

Article 3 Requirement for Advancement

In order to advance from the College of Arts and Sciences to the Faculty, students must complete the required courses at the College of Arts and Sciences and pass the examinations therefor.

Article 4 Semester

The academic year shall be divided into the following two semesters:

- Summer Semester: April 1 through September 30
- Winter Semester: October 1 through March 31 of the following year

Article 5 Curriculum

1. Students must complete the compulsory courses and the elective courses set out in the Appended Table.
2. The allocation of courses and class hours shall be determined upon discussion by the faculty council and announced in advance.

Article 6 Course Registration

Students shall register for the courses they intend to take each academic year to the dean of the Faculty within the designated period.

Article 7 Completion of Courses of Another Faculty

Students may take courses of another faculty. In such case, the student must obtain approval from the dean of the Faculty and the dean of the related faculty in advance.

Article 8 Examinations

1. Examinations are held every academic year. However, examinations for exercise courses may be replaced with a report, the number of days attended, the result of study or other assessments.
2. The date of examination will be announced in advance.

Article 9 Examination Grades

1. The examination grades are classified into A+, A, B, C and F; the grades A+, A, B and C represent a pass and F represents a fail.
2. Pursuant to the provisions of Article 14-2 and Article 14-3 of the General Rules on Faculties, the examination grades for courses taken at a university abroad may be assessed as a pass or fail in addition to the assessment of grades in the preceding paragraph.

Article 10 Graduation

Pursuant to the provisions of Article 26 and Article 27 of the General Rules on Faculties, in order to graduate from the Faculty and obtain a Bachelor of Pharmaceutical Sciences or a Bachelor of Pharmacy, a student must have completed courses set out in the Appended Table and passed the examinations therefor during the enrollment period under Article 3 of the General Rules on Faculties.

Article 11 Readmission, Admission to Senior Division and Transfer to Another Faculty

The handling of students who apply for readmission, admission to the Senior Division or transfer to another faculty as set out in Article 9 and Article 10 of the General Rules on Faculties shall be separately prescribed upon discussion by the faculty council.

Article 12 Handling of Completed Courses

The handling of courses and the number of credits, and the program duration and maximum period of enrollment for any student admitted under the preceding Article shall be separately prescribed upon discussion by the faculty council.

Article 13 Research Students and Auditors

The handling of research students and auditors set out in Chapter 10 and Chapter 11 of the General Rules on Faculties shall be separately prescribed upon discussion by the faculty council.

Article 14 Supplementary Rules

Any necessary matters additional to the provisions of these Rules and relating to the curriculum of, examinations for, advancement and admission to, and graduation from the faculty shall be separately prescribed upon discussion by the faculty council.

Supplementary Provisions

1. These Rules shall come into force on April 1, 1996.
2. With regard to persons who entered the Faculty on or before March 31, 1996 and are still enrolled, the provisions in force then shall remain applicable.

Supplementary Provisions

1. These Rules shall come into force on April 1, 1997.
2. With regard to persons who entered the Faculty on or before March 31, 1997 and are still enrolled, the provisions in force then shall remain applicable.

Supplementary Provisions

1. These Rules shall come into force on April 1, 2000.
2. With regard to persons who entered the Faculty on or before March 31, 2000 and are still enrolled, the provisions in force then shall remain applicable.

Supplementary Provisions

1. These Rules shall come into force on April 1, 2001.
2. With regard to persons who entered the Faculty on or before March 31, 2001 and are still enrolled, the provisions in force then shall remain applicable.

Supplementary Provisions

1. These Rules shall come into force on April 1, 2002.
2. With regard to persons who entered the Faculty on or before March 31, 2002 and are still enrolled, the provisions in force then shall remain applicable.

Supplementary Provisions

1. These Rules shall come into force on April 1, 2003.
2. Notwithstanding the provisions of the revised Appended Table, the provisions before revision shall apply to persons who entered the Faculty on or before March 31, 2003.

Supplementary Provisions

These Rules shall come into force on April 1, 2004.

Supplementary Provisions

These Rules shall come into force on April 1, 2005.

Supplementary Provisions

1. These Rules shall come into force on April 1, 2006.
2. Notwithstanding the provisions of the revised University of Tokyo Rules for the Faculty of Pharmaceutical Sciences, the provisions before revision shall apply to persons who entered the Faculty or the Junior Division on or before March 31, 2006.
3. Students may enter the reformed Department of Pharmaceutical Sciences or the Department of Pharmaceutical Sciences on or after April 1, 2008.
4. The transitional measurements in relation to the revision shall be prescribed separately.

Supplementary Provisions

These Rules shall come into force on April 1, 2007.

Supplementary Provisions

These Rules shall come into force on April 1, 2008.

Supplementary Provisions

1. These Rules shall come into force on April 1, 2010.
2. The transitional measurements in relation to the revision shall be prescribed separately.

Supplementary Provisions

These Rules shall come into force on April 1, 2012.

Supplementary Provisions

These Rules shall come into force on April 1, 2014.
