Visva-Bharati, Santiniketan

In 1863, Debendranath Thakur, father of Nobel Laureate Rabindranath Thakur (popularly known as Tagore) purchased seven-acre plot of land at the site of the present institution. Soon a house was built in known as Santiniketan (the abode of peace). Gradually the entire area came to be known as Santiniketan. In 1901, Tagore setup a Brahmacharyasrama, a school for children. He sought to realize the intrinsic values of the ancient education in India. Simplicity was a cardinal principle. Classes were held in open air in the shade of trees where man and nature entered into an immediate harmonious relationship. He dreamt of designing the educational system in such a manner that would act as a centre for religious, national and global harmony. Thus, Tagore's Santiniketan school evolved into an unconventional university, called Visva-Bharati, Founded in 1921, Visva-Bharati was declared to be a Central University and an Institution of National Importance in 1951. Visva-Bharati, since inception, is a pilgrimage for education and culture. (website: www.visva-bharati.ac.in)

Indo-Japan Relation & Visva-Bharati

Nippon Bhavana, an institute in Visva-Bharati is the centre for fostering Indo-Japanese relations, contact and exchange. It has a library consisting of books, mostly in Japanese written on and about Japanese life and culture. Indo-Japanese relation, etc. Japan Foundation makes a regular contribution of books. Nippon Bhavana, in collaboration with Japan Foundation, invites Visiting Scholars, Artists, Scientists from Japan, arranges seminars and symposia on Japanese culture and Indo-Japanese cultural relations, arranges Indo-Japanese cultural functions, sends academic and cultural troupes to Japan and receives academic and cultural troupes from Japan, organises Indo-Japanese festivals. Nippon-Bhavana has been helping Visva-Bharati to enrich its international character as well as to strengthen the cultural bond between Japan and India.

Department of Physics, Visva-Bharati

The Department of Physics, Visva-Bharati was established in 1963 with a provision for teaching at the B.Sc. Honours level. Subsequently, the M.Sc. teaching programme was started in 1968 along with the efforts to develop research facilities in Physics. Initially the department laid more emphasis on theoretical research due to its constraints. Gradually, with the support from different funding agencies, research works on theoretical as well as experimental physics had been started on a wide range of fields (e.g., astrophysics, cosmology, condensed matter physics, materials science, mathematical physics, microwave electronics, nanoscience, nuclear physics, particle physics, quantum mechanics, quantum optics). The department is an associate centre of the Theoretical Physics Seminar Circuit. Some of the faculty members are having research collaborations with institutions within the country as well as abroad.

Indian JSPS Alumni Association

The Indian JSPS Alumni Association (IJAA) was founded in the year 2006, with the objectives to promote and advance scientific exchange, research and cultural collaboration between India and Japan, to encourage collaborative research amongst the JSPS Fellows and their host professors as well as to provide a common platform of the Indian JSPS Fellows. Among its several scientific activities, IJAA organizes an international conference every year in the emerging fields of science and technology under the sponsorship of JSPS.
