- 5. The Student shall abide by the laws, rules and regulations, and codes of conduct set forth by the authority of Japan as well as the host institution.
- 6. The Student understands that the personal data such as name and contact details obtained by the International Exchange Group of the UTokyo Administration Bureau may be used when they ask the Student to participate in their business (promoting study abroad programs or to advise students wishing to go on study abroad programs) in addition to that required for this Program.)

### **II. SUSPENSION OF PARTICIPATION IN THE PROGRAM**

- (4) The Participant is subject to disciplinary action from the host institution.
- (5) The host institution has deemed that the Participant would not be able to make the required academic achievements.
- (6) Security and safety in the host institution's country deteriorate.
