## 東京大学校友会(東京大学の全学同窓組織)

2024年に発足20周年を迎える東京大学の全学同窓組織で、団体会員(310以上の卒業生団体が登録済み)と個人会員(存命の卒業・修了生20万名、在學生、教職員)、家族会員から成ります。校友会の意思決定は、宗岡正二会長、藤井輝夫名誉会長(総長)以下役員36名並びに団体会員と個人会員を代表する代議員約350名が行い、具体的な企画、活動は、幹事及びサポーター(卒業・修了生ボランティア)約80名が担っています。

校友会の活動としては、卒業・修了生向けには秋のホームカミングデイ(大学と共催)が最大のイベントであり、在學生を含む全世代の同期学年会の形成推進や、在學生向けの就活支援・特別行事の開催(例:2022年6月のフジコ・ヘミング演奏会)にも注力しています。また、年2回、大学広報誌「淡青」と合本で会報「東大校友会ニュース」を発行しています。

校友会の通常経費(物件費、人件費)等年間数千万円を賄うため、2021年度会則改正で会費規定が新設され、各会員(団体、個人)から1回きり1万円の会費納入をお願いしています。会費納入は義務ではありませんが、会費を納入した団体会員、個人会員はそれぞれ、秋の代議員会での議決権、個人代議員の選挙権を有し、V会員(Voting Member)と呼ばれ、様々な特典が得られます。一方、2022年度新設の家族会員(在學生保護者、個人会員配偶者)の会費は1回きり2万円です。

## 団体V会員

団体会員は、学部・学科の同窓会、国内外の地域同窓会、運動部・サークルのOBOG会等310団体(2022年末)です。各団体会員には団体代議員1名を選出いただいておりますが、会費納入済み団体会員(団体V会員)の団体代議員は、代議員会の議案審議で議決権を行使できます。また、団体V会員には、校友会の業務委託先アルムノートの名簿管理システム「Aクラウド」を提案させていただくとともに、当該団体の構成員の校友会会費納入(個人V会員化)促進にご協力いただいております。団体会員の会費納入は、原則として銀行振込でお願いしています(校友会事務局にご照会ください)。

## 個人V会員

個人会員は卒業・修了生、在學生、教職員の合計25万名に及びます。会費納入の呼びかけに応じて2022年中に5,300名以上が会費を納入し、個人V会員となっています。個人V会員は、  
(1)個人代議員選挙(2023年度より3年毎に実施)の選挙権、被選挙権を有し、  
(2)専用メルマガ「V通信」を四半期毎に受信でき、  
(3)専用ウェブサイト「V会員サイト」への登録・アクセスにより校友会に関する情報閲覧や特典享受、同期間や世代間交流への参加が可能です。個人会員の会費納入は、原則として校友会の業務委託先メタップスページの決済システム(ペイシス)よりクレジットもしくはコンビニ決済でお願いしています。以下のQRコードから入力・決済いただけます。

## 家族会員

在學生の保護者(父母等)、個人会員の配偶者は、会費2万円の納入により家族会員となれます。家族会員は、「V会員サイト」への登録・アクセスにより校友会に関する情報閲覧や特典享受、代議員会へのオブザーバー参加が可能です。また、家族会員と校友会役員、大学幹部との懇談機会も随時設けます。家族会員(在學生保護者)の会費納入は、原則として銀行振込でお願いしています。以下のQRコード、URLから申込フォームに入力いただき、記載されている校友会銀行口座に振込いただきます。家族会員、個人会員の会費はそれぞれ2万円、1万円ですが、在學生(個人会員)と保護者(家族会員)の会費をまとめて納入いただく場合、合計28,500円と1,500円割引になります。

# UTokyo Alumni Association (UTAA) V-Membership and Family Membership

## About the UTokyo Alumni Association

The University of Tokyo Alumni Association (UTAA), established in 2004, is the overall alumni organization of the University of Tokyo (UTokyo) and consists of Group Members (310+ registered alumni groups), Individual Members (200,000 living alumni, as well as all students and faculty/staff members) and Family Members.

36 executives, led by Mr. Shoji Muneoka, President and Dr. Teruo Fujii, Honorary President (UTokyo President), and some 350 delegates representing Group Members and Individual Members have decision-making roles. 80 councilors and supporters (alumni volunteers) are specifically in charge of planning and the activities themselves.

UTAA's activities include hosting (jointly with UTokyo) the annual Homecoming Day each autumn as the biggest event for alumni and developing class gatherings for students and class reunions for alumni. UTAA has also been avidly providing career search support and sponsoring special events for students (e.g. Fuzjko Hemming Solo Concert in June 2022). In addition, UTAA publishes its newsletter, "UTAA News" which is in the same booklet as the UTokyo PR magazine, "Tansei", biannually.

In order to cover UTAA's ordinary expenses (material and personnel expenses) and other costs, which amount to tens of millions of yen, the UTAA's Constitution was amended in 2021 to include an article addressing membership fees. Accordingly, UTAA requests that each Group and Individual Member pay a one-time membership fee of JPY 10,000. While the membership fee payment is not compulsory to maintain membership in the UTAA, Group Members and Individual Members who have paid their membership fees obtain the status of "V-Members" (Voting Members) granting them (i) the right to vote at the Conference of Delegates held each autumn and (ii) the voting rights/eligibility for elections of Individual Delegates, respectively, as well as various other privileges.

On the other hand, the one-time membership fee for "Family Member" (a student's guardian or an Individual Member's spouse), a membership category introduced in 2022, is JPY 20,000.

## Become a Group V-Member

As of the end of 2022, UTAA has 310+ Group Members including alumni associations of Faculties/Departments, regional alumni associations in and out of Japan and alumni groups of sports clubs and circles. Each Group Member is asked to appoint one Group Delegate. Group Delegates of Group Members that have paid membership fees (Group V-Members) can exercise their voting rights for deliberations at the Conference of Delegates. Group V-Members may also utilize a member registry system run by Alumnote, UTAA's subcontractor, and are asked to encourage their own members to pay UTAA membership fees (to become Individual V-Members). Membership fees for Group Members should be made via bank transfer (please contact the UTAA Secretariat).

## Become an Individual V-Member

There are as many as 250,000 Individual Members, comprising of alumni, students and faculty/staff members. Following our request for membership fee payments, more than 5,300 individuals paid their membership fees in 2022 and became Individual V-Members. Individual V-Members can:

- (1) vote at and run for Individual Delegate Elections (to be held every three years starting in 2023);
  - (2) receive the mail magazine, 'V Quarterly', every quarter; and
  - (3) register for and access the 'V-Member Web' to read UTAA information/reports, enjoy various other privileges and participate in exchanges and interactions with others in the same and different graduating classes.
- Membership fees for Individual Members should be made via credit card or at convenience stores through the payment system run by Metaps Payment (Paysys), UTAA's subcontractor. Please make the payment by accessing the QR code below and entering the required information.



## Become a Family Member

Guardians (such as parents) of students can become Family Members after paying a membership fee of JPY 20,000 each. Family Members can read UTAA information/reports, enjoy various other privileges by registering on and accessing the 'V-Member Web', and attend meetings of the Conference of Delegates as observers. Family Members will also have opportunities to meet and talk with UTAA and UTokyo executive members.

Membership fees for Family Members (guardians of students) should be made via bank transfer. Please access and fill out an application form using the URL or QR code below and make a transfer to one of the UTAA bank accounts described in the form. While membership fees for a Family Member and an Individual Member are JPY 20,000 and JPY 10,000 respectively, if you pay concurrently the membership fees for a student (Individual Member) and a guardian (Family Member), your payment will be JPY 28,500, reflecting a discount of JPY 1,500.
