**1. Notes for Online Application**

The University of Tokyo will select students through internal selection and nominate those selected to UC Davis. Applicants who passed the internal selection will be informed of the online application process. Following the instruction, please complete the application by the deadline set by the International Education Promotion Group. Please prepare in advance a financial statement showing sufficient funds for both tuition and living expenses (tuition: 8,500 U.S. dollars, living expenses: 4,500-5,500 U.S. dollars per academic quarter).

**2. Procedures after being selected as a participant**

Students who are selected to participate in the program should receive an “Admission Packet” through the post from UC Davis. It is the students’ own responsibility to complete all the necessary procedures including travel arrangements to UC Davis based on the instructions provided by UC Davis.

**3. Payment**

Students will be provided with invoice with pricing sheets, due dates, and payment instructions upon confirmation of admission to the GSP. Please be sure to make all payments before the deadline. Course registration will only be confirmed after receipt of payment. In the event students have to withdraw from the program after your payment, please be aware that they have to abide by the refund policy and procedure set by UC Davis. Students can pay by credit card or international wire transfer.

\* Payment MUST reference quarter, year, full student name, and home university.

**4. Insurance and safety management during the program**

While GSP students are required to purchase UC Davis International Student Health Insurance Plan., UTokyo students are required to take out both the JEES “*Futai Kaigaku*” and the Overseas Student Safety Management Assistance (OSSMA) from Emergency Assistance Japan Co., Ltd. for insurance and safety management during study abroad at their own expense. Taking out these insurance and service will be one of the requirements for participating in this study abroad program (This will not be paid for by the University). Details will be sent to students who are accepted into the programs at a later date. By purchasing the “*Futai Kaigaku*”, UTokyo students may be waived from having to purchase the UC Davis sponsored plan. The students will receive a form after they are admitted to UC Davis that enables them to be exempt from the UC Davis sponsored plan. However, in the event that exemption is not granted,

students wishing to participate in this program must obtain both the “*Futai Kaigaku*” and the UC Davis sponsored plan. Please keep this point in mind when applying.

## **5. Accommodation**

UC Davis offers the following housing options for Global Study Program students. Students make their own housing arrangements by themselves with guidance from GSP advisors.
