

## University-wide Education Program in AY2025

The University of Tokyo offers university-wide education programs that link different fields of academic knowledge to address new challenges.

The University-wide Education Program is a program in which students can take lectures, seminars, etc. offered by multiple faculties/graduate schools as a single program in accordance to a specific theme. You can take this program in addition to the curriculum of your faculty or graduate school.

In AY2025, 13 programs on different themes are offered.

A certificate will be awarded to those who have completed the program.

### **Eligibility**

#### **University-wide Undergraduate Education Program:**

Undergraduate students in the Senior Division (including students informally approved) and graduate students of the University of Tokyo

#### **University-wide Graduate Education Program:**

Graduate students of the University of Tokyo

Please note the rules and regulations of your faculties or graduate school when taking the program.

## FAQ

### **1. What are the necessary procedures to participate in the programs?**

Some programs require pre-registration. Please read each program's website carefully to confirm if pre-registration is required.

### **2. Are the courses approved for a program the same every year?**

Courses approved for a program may vary from year to year. When registering for a course, be sure to read each program's website to check if the course is designated as a program course for that year.

Credits earned in years when the subject was not designated as an accredited subject for a program cannot be used to satisfy the program's completion requirements.

### **3. What should I check when I wish to check a program's approved courses?**

Please make sure to check that the "Academic Year", the "Course Title", and the "Course Code" match the courses you will take (or have taken).

Please note that even if you earn credits for a course with a different course code from the designated one, those credits cannot be used to satisfy the completion requirements of the designated program.

### **4. Some courses are designated as approved courses in more than one program. If I acquire credits for those courses, will they count as credits for each program?**

Yes, they will be recognized as credits for each program.

For example, "Introduction to the Theories of Diversity and Inclusion" is an approved course both for *Diversity and Inclusion* and *Human Integrative Science and Education of Mind*. The credits for this course will be counted as credits for both programs.

### **5. I took courses approved for the program and earned credits before this program had started. Can these credits be used to satisfy the program's completion requirements?**

No. Only credits earned after the program start date can be used to satisfy the program's completion requirements.

Whether or not you can retake courses you have already taken depends both on the rules and regulations of faculties or graduate schools offering the course and the policy of the faculty or graduate school you belong to.

### **6. I earned some of the credits required for completion of the University-wide Undergraduate Education Program while I was enrolled in the Senior Division of an undergraduate faculty/college. In that case, is it possible to combine the credits earned in the Senior Division of the undergraduate faculty/college and the credits earned in the graduate school and count them toward a program completion?**

Yes. However, as courses in the "University-wide Undergraduate Education Program" are offered in the Senior Division of an undergraduate faculty/college, it will depend on the policies of the graduate school you belong to as to whether or not the credits earned from the "University-wide Undergraduate Education Program" while in the graduate school can be included in the credits required for completion of a graduate program.

### **7. When and where can I receive the completion certificate for the program?**

How certificates are awarded varies depending on the faculty/college/graduate school, so please contact your faculty/college or graduate school for further details. For example, for the *Science, Technology, and Innovation Governance*, the certificate will be awarded by the program.

The date of completion of a program is the date of graduation from an undergraduate school or the date of completion of a graduate school (or the date of withdrawal from a doctorate program after completing a program's course requirements).
