

Call for Applications:

Assistant Professor (Full-time) Position

1. Title and Number: One full-time Assistant Professor position
2. Starting Date: As early as possible on or after December 1, 2025 (negotiable)
3. Term of Appointment: Five years
4. Renewal: Renewal may be allowed once only, with the renewed term set at five years.
The decision on renewal shall be made based on a comprehensive evaluation of factors including the progress of the work in which the employee is engaged, job performance, work attitude, health condition, budgetary status, and the volume of work at the end of the contract period.
5. Trial Period: Fourteen days from the date of appointment
6. Work Location: Hongo Campus, The University of Tokyo
7-3-1 Hongo, Bunkyo-ku, Tokyo
Note: The work location may be changed as specified by the University of Tokyo. As a general rule, assignments or transfers will not be made without the individual's consent, in accordance with Article 4 of the University of Tokyo Employment Regulations for Faculty Members.
7. Job Description: The successful candidate will engage in research and education in the field of system software at the Department of Computer Science, Graduate School of Information Science and Technology, including teaching responsibilities for the "System Programming Experiments" course.
Note: Reassignments or concurrent duties may be ordered, but in principle not against the individual's will, as per Article 4 of the University of Tokyo's Employment Regulations for Faculty Members.
8. Working Hours: The position is subject to the discretionary labor system for professional work, and the appointee is deemed to have worked 7 hours and 45 minutes per day.
9. Holidays: Saturdays, Sundays, national holidays, and Year-end and New Year holidays (December 29 – January 3)
10. Leave: Annual paid leave, special leave, etc.
11. Salary: Determined based on academic background and work experience.
A salary increase system is available.
12. Allowances: Includes biannual bonuses, a commuting allowance (up to JPY 55,000 per month, subject to conditions), and other allowances as specified by the University.
13. Social Insurance: Enrollment in the Mutual Aid Association of the Ministry of Education, Culture, Sports, Science and Technology, as well as employment and workers' compensation insurance in accordance with legal requirements.
14. Qualifications:
 1. Applicants must hold a doctoral degree by the time of appointment.
 2. Applicants must have a proven track record in system software research.
 3. Applicants must have sufficient proficiency in Japanese to conduct lectures, supervise students, and fulfill administrative responsibilities.
